#### **E. Discussion Items**

1. Billbacks

It is the SELPA Director's recommendation that billbacks be based on an average cost and be the same for each district.

It was agreed upon that each superintendent would discuss this concept with his or her business office and come prepared to discuss this further at the April meeting. Ideas such as using a simple formula for calculating this cost that is used consistently by each district and if change is expected, agreeing to a gradual movement towards this change if needed were discussed.

2. It is the SELPA Director's recommendation that we hire a 1 FTE program specialist to begin the work of our regional ED elementary program which will allow us to provide a broader continuum of services/programs that will result in a reduced number of elementary students being placed in nonpublic schools.

It was agreed upon that this item would be discussed further at the April meeting and that the SELPA Director would provide financial information regarding the fiscal impact of this position as it pertains to the WACSEP budget.
