I. SELPA Director Report

Ms. Janet Queneau shared the new WACSEP website with the Joint Powers Board. She thanked the WACSEP team, especially Secretary IV, Adahena Gutierrez, for entering all of the information on the new platform. She also shared that WACSEP now has an Instagram account that can be found by the @WACSEP handle, in addition to the existing WACSEP Facebook. The vision is for WACSEP platforms to be a hub for resources and support for all families and member district staff. The educator portion of the website, that will require a login, is expected to be available at the end of the summer. An email blast will be going out to notify families of our new website.

Ms. Janet Queneau shared the information regarding the upcoming Legislative Sharing Day, sponsored by the SELPA Association of California, in Sacramento on May 3, 2023. Two Community Advisory Committee parents and Ms. Queneau will be attending the morning presentations from the SELPA Association, and then attending meetings with Senator Bob Archuleta's office and Assemblymember Blanca Pacheco's office to discuss support of special education.

classroom which had only three students in the room because all of the other students from the class were attending general education classes, which is a great thing.
