H. SELPA Director Report

Ms. Queneau reported that WACSEP is in the midst of a parent training series. There has not been a lot of turnout for the Spanish parent trainings, but the English trainings have been increasing in attendance each time. WACSEP sent a second parent email blast promoting the parent training series that will run through December. The WACSEP staff is doing a wonderful job presenting and have received positive feedback.

Ms. Queneau shared the Mrs. Gloria Ruiz, former CAC Chairperson, current parent representative for the Whittier Union High School District, was appointed to the Advisory Commission on Special Education for California; the Advisory Commission provides recommendations and advice to the State Board of Education, the State Superintendent of Public Instruction, the Legislature, and the Governor in new or continuing areas of research, program development and evaluation in California special education. Mrs. Ruiz went through a rigorous process to be appointed to that position and was sworn in by Senator Bob Archuleta; she is a tremendous advocate for students with disabilities and for our SFLPA.

The Joint Powers Board requested that Ms. Queneau extend a congratulatory message

to Mrs. Gloria Ruiz on their behalf.
