H. SELPA Director Report

Ms. Queneau reported that WACSEP is continuing to provide services virtually. The WACSEP staff has been creative in how they administer services and supports, especially with the preschool population. Additionally, the Mental Health Department has added processes to make sure the staff is socially-emotionally supported throughout this time.

Ms. Queneau shared that the Community Advisory Committee (CAC) met in November and would like to move forward with the Disability and Transition Resource Fair.
