### H. SELPA Director Report

Ms. Janet Queneau reported that WACSEP had welcomed all staff back on August 15th and several staff members had worked throughout the summer on summer preschool assessments. She reported that WACSEP had begun holding trainings for teachers and service providers; to date, seven trainings had been held at WACSEP, which included SEIS trainings, classroom management strategies, and school psychologist orientation. She stated that everyone at WACSEP is excited to support students with special education needs throughout the SELPA in the new school year.

Ms. Janet Queneau reported that the Governor's budget for 2022-23 was finalized. The approved budget included a \$500 million budget increase for special education which increased the base rate to \$820 per ADA. Additionally, she shared that part of the budget changed eligibility for Regional Center services from an overall delay of 33% to 25%. Due to the change in threshold, all WACSEP preschool intake assessment teams are anticipating the number of assessments to increase; it is required that all children who are Regional Center clients be assessed by school districts prior to turning three years old. WACSEP conducts all of these assessments on behalf of the member districts.

Ms. Janet Queneau shared that WACSEP was collaborating with the Eastern Los Angeles Family Resource Center (ELAFRC) to host trainings at WACSEP. ELAFRC recently received a grant to be a Family Empowerment Center. The ELAFRC office is located in Alhambra which is a long distance for some in our community to travel to for trainings, so it would be great to have them hold trainings in the area.

#### I. Board Member Reports

Marc Patterson, Superintendent of East Whittier City School District, welcomed the new Joint Powers Board members. He reported that the district has a new Director of Special Education, Mrs. Elisa Clark, and appreciated the support given as she transitioned into her new role.

Dr. Marco Villegas, Superintendent of El Rancho Unified School District, thanked the Joint Powers Board for the warm welcome. He shared that the district had a veteran director of special education with a good system in place. He was looking forward to growth.

Dr. William Crean, Superintendent of Little Lake City School District, welcomed everyone back. He shared that the district had a smooth opening of the school year and gave a shout out to the Whittier Union High School District Transportation Department for an incredible job in the summer and the beginning of the school year. He was impressed with the concern drivers showed with doing well with their routes and taking care of kids. Additionally, there have not been any disruptions in routes with the opening of the middle and high schools.

Dr. William Gideon, Superintendent of Los Nietos School District, thanked all the superintendents and Ms. Janet Queneau. He reported that he also was impressed with the Whittier Union High School Transportation Department and although Los Nietos School District had started sooner than other districts, he had not noticed any interruptions in transportation with the starting of school in other districts. He shared that he would be asking Ms. Janet Queneau for support as the district works with the Los Angeles County of Education on special education items. He thanked Ms. Kolia Ponce, Program Specialist, for the support she had provided to special education teachers.

Dr. Gary Gonzales, Superintendent of South Whittier School District, welcomed everyone back. He reported that the district had a good summer and complimented the summer school program. He shared that the district has continued to enroll students and had exceeded enrollment expectations.

Dr. Monica Oviedo, Superintendent of Whittier Union High School District, welcomed the new member to the Joint Powers Board. She reported that the Whittier Union High School Transportation Department had a new director, Karen Torres. Ms. Karen Torres had previously served as director in a big district and was a vocational specialist; she was building the team of drivers to know how important their roles were in setting the tone for the day. She also shared that their experienced Director of Special Education, Dr. Anthony Truong, was ready to take on the school year. Lastly, she shared that the Whittier Area School Administrators (WASA) welcome back breakfast would take place at Rio Hondo College on September 9, 2022 and the community breakfast would be held at the district on Friday.

Dr. Brad Mason, Superintendent of Whittier City School District, welcomed the new members to the Joint Powers Board which offered a lot of collaboration and support. He thanked Ms. Janet Queneau for her leadership. He also complimented the Whittier
