#### **H. SELPA Director Report**

Ms. Janet Queneau reported that the first Community Advisory Committee (CAC) Board meeting occurs tomorrow, September 15, 2022. The CAC would be electing a new Chair and Vice Chair. She also shared that Little Lake City School District has a new alternate voting member.

Ms. Janet Queneau reported that WACSEP staff continue to provide trainings for WACSEP and district, both general and special education, staff. The trainings within the last two weeks have included classroom management strategies, Nonviolent Crisis Intervention Training, Special Education Information System (SEIS), and Individual Education Plan (IEP) basics. .

Ms. Janet Queneau thanked the Whittier Union Personnel department, especially Kristin Kooiman and Kenna Tarkington, for their help with last minute new staff. Lastly, she thanked the WACSEP team for supporting the Los Nietos School District when needed.

#### I. Board Member Reports

Marc Patterson, Superintendent of East Whittier City School District, thanked the new Director of Special Education for setting up additional layers of support for new Instructional Aides III and IV. The director has set up monthly trainings for new instructional aides that provides support in moderate to severe classrooms and shadowing of other aides.

Dr. Monica Oviedo, Superintendent of Whittier Union High School District, reported that the district approved an adjustment to the work day of instructional aides. The adjustment increased their work day hours from 5.5 hours a day to 6.5 to allow for support to students from the beginning to end of the school day. Additionally, She shared that she had the opportunity to conduct field visits of the adult transition program out in the community and was able to observe students working hard at Lascari's, Roadhouse Grill, and an East Whittier thrift shop. She asked that we support our local small businesses that support our students.

Dr. William Crean, Superintendent of Little Lake City School District, reported that the district has had Teachers on Special Assignment (TOSAs) in the areas of Math, Science, English Language Arts, but this year had added a Special Education TOSA to enhance the special education program. He shared that the Autism Focus Program is up for a Golden Bell Award; the validation meeting would be taking place next Monday.

Dr. Gary Gonzales, Superintendent of South Whittier School District, reported that the district was looking into increasing instructional aides to full time to help with retention and better serve students. He shared that the Mental Health Program had a validation meeting on September 26, 2022 for a Golden Bell Award. The program had grown over the last five years due to its proactiveness and responsiveness to students.

Dr. Marco Villegas, Superintendent of El Rancho Unified School District, shared that he was impressed with the special education program in El Rancho Unified School District. They have about 1000 students with IEPs; based on data, the majority of those students receive the majority of instruction in general education making it important to include general education as part of the team. They are looking at how to best support students with IEPs as a whole. Additionally, he shared that he hadn't had the chance to observe the adult transition students at work sites but has seen them hands-on in the community. He looked forward to supporting the special education team.

Dr. Brad Mason, Superintendent of Whittier City School District, shared that he appreciated the Joint Powers Board for the collaboration and brainstorming regarding best practices. Additionally, he reported that the district had 32 employment vacancies, mostly instructional aides and part time positions. He thanked Ms. Janet Queneau and her team for their recent support.
