H. SELPA Director Report

Ms. Queneau shared that the WACSEP Community Advisory Committee (CAC) will sponsor a California Autism Professional Training and Information Network (CAPTAIN) parent workshop in October, presented by WACSEP staff, Lisa Torres and Inger Johnson-Quezada. This is the second time that CAC sponsored this workshop, WACSEP is currently working on getting flyers approved through the districts and has posted the training flyer on the WACSEP website. Additionally, she reported that the CAC Board re-elected Gloria Ruiz as Chair and Hilda Lopez as Vice Chair.

Ms. Queneau reported that the California Department of Education is requiring every SELPA in the state to submit an amended local plan using a new template. The districts will be supporting the process through a local plan committee comprised of teachers,

administrators, and CAC parents. Additionally, she shared that an overview of the process was presented at the CAC Board meeting.

I. Board Member Reports

Jonathan Vasquez, Superintendent of Los Nietos School District, thanked Ms. Queneau for rescheduling an Administrators' Academy training for his staff. All Los Nietos School District administrators will be able to attend the training. Mr. Vasquez also thanked Ms. Ruiz for her comments and the CAC for supporting parents in demystifying the IEP process.

Dr. William Crean, Superintendent of Little Lake City School District, shared that WACSEP staff member, Vira Caro-Michel, had conducted CAPTAIN teacher trainings in the past which had been great training for teachers and thought it is good that CAC is holding a CAPTAIN workshop for parents.

Maria Martinez-Poulin, Superintendent of Whittier City School District, thanked Ms. Queneau for the parent workshops and reported that the workshops had been well received in the community. Additionally, she thanked WACSEP clerical staff for their support in staying organized with Joint Powers Board activities.

Marc Patterson, Superintendent of East Whittier City School District, shared the East Whittier City School District would be recognizing two students from the district who overcame challenges at their district Stars Awards.

Dr. Frances Esparza, Superintendent of El Rancho Unified School District, thanked Ms. Queneau for meeting with her and providing an overview of WACSEP. Additionally, she thanked Ms. Queneau and Mr. Dean Cochran for their support.
