## I. SELPA Director Report

Ms. Queneau shared that the WACSEP Behavior and Mental Health Departments worked collaboratively to put together a parent training series. The trainings will be a 30 to 45 minute virtual meeting with time for parent questions, each will focus on one strategy. The trainings will be held in English at 5 p.m. followed by in Spanish at 6 p.m. on the same days. The first training will take place on September 30, 2020. WACSEP is emailing the flyers to parents and working with member districts to have the flyer posted on their websites. Additionally, she shared that the CAC Board was also excited about the topics and was part of their request to have parent trainings around behavior and working with their own children at home during this unprecedented time.

Ms. Queneau reported that the CAC Board elected a new Chairperson and Vice Chairperson for the 20-21 school year. She shared that Ms. Gloria Ruiz had completed her term according to bylaws as Chair but would be continuing as a Board member. Additionally, she announced the new Chairperson, Hilda Lopez, parent representative from East Whittier City School District and the new Vice Chairperson, Veronica Ramirez, parent representative from El Rancho Unified School District.

Lastly, Ms. Queneau reported that the SELPA is working diligently to support students virtually and prepare for the eventuality of returning to in-person instruction.

#### J. Board Member Reports

Marc Patterson, Superintendent of East Whittier City School District, thanked Ms. Queneau for her responsiveness and putting together the Parent Workshop Series.

Dr. Frances Esparza, Superintendent of El Rancho Unified School District, thanked Ms. Queneau for presenting at the El Rancho Unified School District Board meeting. She shared that the Board was happy to hear about all that the SELPA has to offer and for supporting with the parent workshops.

Dr. William Crean, Superintendent of Little Lake City School District, thanked Ms. Queneau for her work on the Special Education Plan and the new Joint Powers Agreement.

Jonathan Vasquez, Superintendent of Los Nietos School District, thanked Ms. Queneau and the WACSEP team for facilitating the parent workshops. The district has been advertising the upcoming parent workshops and hopes for good turnout of parents from the Los Nietos School District. He would be encouraging parents to sign up. Additionally, he thanked Mr. Barber and Mr. Rytky for their responsiveness and great work they are doing for the districts.

Dr. Maria Martinez-Poulin, Superintendent of Whittier City School District, thanked Ms. Queneau and the WACSEP staff for the efforts in drafting a plan to get the best action and support for students across the Whittier area. Additionally, she thanked the Joint Powers Board for the collaboration as they learn about the blueprint for a safer economy and are given direction from the state and the county as to how districts can open up to small cohorts or to hybrid in a safe environment.

Martin Plourde, Superintendent of Whittier Union High School District, thanked Ms. Queneau for keeping the Joint Powers Board focused on the importance of special needs students, working with the Directors of Special Education, and taking into consideration the finances. Additionally, he shared information about Whittier Union Transportation, and requested that the districts, who use Whittier Union for transportation, keep in contact with that department for their current and upcoming needs; this includes planning for bringing students back, as well as support with getting meals to families.

Dr. Gary Gonzales, Superintendent of South Whittier School District, thanked the WACSEP staff for the parent workshop opportunity. Additionally, he thanked the new Director of Special Education, Diana Huizar, and the South Whittier School District staff for doing a wonderful job in dealing with the uniqueness of the pandemic.
