H. SELPA Director Report

Janet Queneau announced that WACSEP welcomed a new Program Manager, Karla Rahiman beginning September 4, 2018.

Janet Queneau also announced that the Community Advisory Committee (CAC) Board elected a new Chair, Gloria Ruiz, and CAC Vice Chair, Hilda Lopez. Additionally, a small CAC workgroup made up of Board members and Directors of Special Education has been assembled to improve communication with families regarding CAC events.

Janet Queneau shared that WACSEP has conducted multiple staff trainings at various sites including a training by Kristine Ramos on the transition of CASEMIS and CALPADS. Janet thanked Kristine for a job well done in explaining how to capture the data that will be shared with the state.

Additionally, WACSEP continues to work on getting bids for the heating and cooling system to have a comfortable training environment at WACSEP. She also advised that WACSEP is taking preliminary steps in making the campus safe and is now a closed campus which will require visitors to sign in and wear a visitors badge while on campus.

I. Board Member Reports

Marc Patterson, Superintendent of East Whittier City School District, shared that he attended the last CAC Board meeting and commended the CAC Board for discussing some of the programs offered and how they can support students and families.

Maria Martinez-Poulin, Superintendent of Whittier City School District, reported that teachers are preparing for parent conferences and are in full swing in regards to parent outreach.

Karling Aguilera-Fort, Superintendent of El Rancho Unified School District, reported that the initial challenges experienced in the first few weeks with transportation are being resolved. He has noticed improvements in communication and in customer service.
